Application process is a 1 coat application at 300-350 square feet per gallon. Refer to listee's data sheet for additional detailed product description and operational considerations.

INSTALLATION:	In accordance with listee's printed installation instructions, applicable codes and ordinances and in a manner acceptable to the authority having jurisdiction.
MARKING:	Listee's name, product name and ETL label.
APPROVAL:	Listed as a surface coating material for application to SYP plywood sheathing, OSB sheathing, and SYP lumber for interior use only. The coatings are applied at the rates specified in accordance with the manufacturer's installation instructions. Authority having jurisdiction should be consulted prior to installation.
NOTES:	Not approved for exterior use and in the Wildland Urban Interface Area (WUI). The 2022 California Building Code, Chapter 7A, Section 703A.5.3, prohibits the use of paints, coatings, stains or other surface treatments as an approved method of protection required for WUI areas.
